Cares Fund to Homeward Bound in Asheville to support the Room In The Inn COVID operations at local motels. Motion Passed.

The November Barbecue was also very successful with \$1500 being raised. Profits after expenses will be donated to Charlie's Angels.

Fr.J. informed the Vestry that 13-15 Parishioners register each Sunday for in person Eucharist.

Fr. J. then led a discussion on how Advent Season Services may be held. With the current increase in the virus it may be necessary to stop in person services.

Fr. J. closed the meeting with Compline.
